**56. Matters arising:**

- i. There was no news on the pavement. It was resolved to postpone the protest until an answer was received from the Minister.
- ii. It was reported that phase one of the project to create a playground was finished. The paths have been completed. It was resolved to authorise a payment of up to £2000 on the project. There was no news on the lease. It was reported that the project had received £150 from the *Cambrian News* 10K Fund.
- iii. A letter about the lane to the station was noted. An official complaint about lack of disabled access from Mrs L. Hughes is being prepared. It will go to Network Rail, Mark Williams and the Equality Commission.
- iv. It was reported that money for a defibrillator had gone to Welsh Hearts. It should arrive in about six weeks.
- v. It was noted that rubbish collection was continuing.
- vi. It was noted that there was no progress with regards to the Community Speedwatch Scheme.
- vii. It was reported that no meeting with Simon Williams, Tai Ceredigion, about visiting empty property in the community had happened as the empty property had all been sold by now.
- viii. It was reported that the Clerk has not succeeded in contacting the officer responsible for recycling banks yet. She will ask County Councillor ap Gwynn for his e-mail address.
