Minutes of the meeting held on 13 September 2017

**33. Matters arising:**

i. It was resolved to ask for an explanation of the Active Travel Routes – why does the community not score higher? It was noted that parents are concerned about the safety of their children. It was resolved also to ask for the scrub on the verges of the road to be removed. It was noted that the community is a pinch point on the A487. It was resolved to write to Elin Jones AM and Ben Lake MP about the matter.

ii. It was reported that the Chair had met with the RSPB Estates Officer about the playground. A fence has been placed around the site and the lease is on its way.
